Parking and Driving Registration Permission

Students who wish to drive to and/or from FHS must read and sign this form and provide the required information. Please be assured that our first concern is for the safety of all of our students. It is our desire that students be able to arrive at and leave school in conditions that promote safety and responsibility. In accordance with that, the following guidelines have been established.

1. Students who drive to school must observe all the rules and procedures determined by the school as well as state and local authorities.
2. Student drivers must possess a valid New York State driver's license. The Main Office will make a copy of the license to keep on file with this form.
3. Students may not drive other students unless the **Student Drivers and Riders** portion of this form (page 2) is completed and signed by **parents of both driver and rider.**
4. Students must obey the **5 MPH** speed limit when on school property and **STOP** at the Southwest corner of the building.
5. Vehicles are not to pass school buses with the red lights flashing (even on the school property).
6. Students may not park in spaces reserved for visitors or the handicapped, unless the student has a legal handicap sticker or tag.
7. No cars are to pull out of the student lot once buses start moving unless you are given a signal from the bus duty person.
8. Students should not attempt to cross the driveway when exiting the school once the buses start moving until you are given a signal from the bus duty person.
8. Reckless or unsafe driving practices are prohibited.
9. Student cannot transport other non-related students to school sponsored activities (such as sporting events) that occur immediately after school such as sporting events. Students cannot transport other students on field trips that are school sponsored.
10. Students are not to tamper with other students' vehicles or horseplay in the parking lot in and around moving vehicles.
11. Students who drive to school must not linger in the car after arriving at school or make trips to the vehicle during the day without permission.
12. All students going to the parking lot must exit through the North side Activity Center doors during afternoon dismissal.
13. Students who have more than 6 illegal tardies in one semester will lose driving privileges for that semester.
